**ORDER:**

In the G.O. first read above, orders have been issued fixing the diet charges to all the boarders in the Government Pre-Matric Minorities Welfare Hostels from class VI to VII @ Rs.338/- per month per boarder and from class VIII to X @ Rs.412/- per month per boarder.

2. The Vice Chairman & Managing Director, A.P.State Minorities Finance Corporation, Hyderabad, in his letter 3<sup>rd</sup> read above has stated that the Social Welfare Department in G.O. second read above has enhanced the diet charges to all the hostel boarders in Government SC, ST, BC Welfare Hostels and Institutions (like Anandanilayams and Child Beggar Homes) including Asharam Schools, Residential Institutions and V.M.Home, Hyderabad @ Rs.475/- per month per boarder for classes VI to VII and @ Rs.575/- per month per boarder for classes VIII to X from the academic year 2008-09 and requested the Government to issue orders extending the revised rates of diet charges to all the borders of Minority Welfare Hostels on par with other Welfare hostellers and also permit the Corporation to incur the expenditure as per revised rates for the existing boarders, wherever the expenditure exceeds the pre-revised rates, but limited to revised rates and wherever the provisions are being purchased with the approval of District Committee on par with other Welfare hostels.

3. Government, after careful examination, hereby enhance the diet charges to all the boarders in the Government Pre-Matric Minorities Welfare Hostels as indicated below from the academic year 2011-12 :-

1.	III to VII	338/- per month per border	475/- per month per border
2.	VIII to X	412/- per month per border	575/- per month per border

4. The Vice Chairman & Managing Director, A.P.State Minorities Finance Corporation, Hyderabad shall work out the exact financial implications for 10 months at revised rates mentioned above and meet the enhanced expenditure for 2011-12 from the respective Head of Account from the budget provision for Financial Year 2011-12.
