ORDER:

In the G.O. 1<sup>st</sup> read above, Government have issued guidelines for sanction of financial assistance for "Mass Marriages of Muslims". The Scheme is renamed as "Marriages of Poor Muslim Girls" and granted an amount Rs.15,000/- under this Scheme for purchase of articles for each couple for Mass Marriages for poor Muslim Girls celebrated on a particular date.

In the letter 2<sup>nd</sup> read above, the Convenor, State Level Mass Marriages Committee, Vice-Chairman and Managing Director, Andhra Pradesh State Minorities Finance Corporation, Hyderabad has requested the government to enhance the amount of each Marriage limit from **Rs.15,000/- to atleast Rs.25,000/-** for conducting Mass Marriages of poor Muslim girls in the state.

3. Government after careful examination, hereby enhance the amount of each Mass Marriage limit from Rs.15,000/- to Rs.25,000/- for conducting Mass Marriages of poor Muslim girls in the State.

4. The Vice-Chairman and Managing Director, Andhra Pradesh State Minorities Finance Corporation, Hyderabad shall take necessary action accordingly.
